C Approve Minutes of the November 1, 2019 Special Meeting of the Joint Budget & Finance Committee

A Motion was made by Committee Member Gaudet, seconded by Committee Member Barber to approve the Minutes of the November 1, 2019 Special Meeting of the Joint Budget & Finance Committee.

Motion passed unanimously.

D Review Joint Budget & Finance Committee Charter

Chairman LaRose reviewed the Purpose & Authority and Responsibilities of the Joint Budget and Finance Committee Charter. Discussion ensued as to the level of budget detail presented to the Committee versus what is reviewed by the Board. It was decided that with respect to certain line items, the Budget and Finance Committee will conduct a quarterly review of budget to actual in the same level of detail as was reviewed by the Committee when approving the 2020 annual budget

With respect to the mandate in the Committee Charter that “at least one member of the Committee shall be a committee financial expert”. The Committee designated Committee Mark Oefinger for this role due to his extensive experience in city budgets.

As there was no further business to come before the Budget & Finance Committee, a Motion to adjourn was made by Committee Member Barber, it was seconded by Committee Member Gaudet.

Motion passed unanimously.
